





POWER OF ATTORNEY

I, the undersigned **RIYAADH NAJAAR** of Spine Road Secondary School, Mitchell's Plain, Cape Town, duly authorized and on behalf of the Progressive Principals Association ("the Association"), do hereby confirm the power of attorney granted to Jonathan Mort of Jonathan Mort Inc, 3A Sir George Grey Street, Oranjezicht, Western Cape (hereinafter called "the agent"), with power of substitution, to be the lawful agent of the Association by means of this power of attorney to commence proceedings in the High Court (Western Cape Division) and do any or all of the following acts or things:

- 4 To defend any action or proceedings brought against the Association in which it may be joined in any court or tribunal in relation to the proceedings instituted by it (including any counterclaim or claim in reconvention made against it), or to compromise any such action or proceedings or consent to judgment therein if the agent shall see fit, and on the Association's behalf to make any claim in reconvention in such action or proceedings and for such relief as the agent sees fit.
- 5 To note, prosecute, withdraw or abandon any appeal which may be allowed by law against any judgment or order made in the Association's favour in any such action or proceedings and to defend any appeal against any such judgment or order made in the Association favour.
- 6 To sign all documents necessary in connection with any such action or proceedings.
- 7 Generally for effecting the purposes aforesaid, to do and cause to be done whatsoever shall be requisite as fully and effectually for all intents and purposes as I or the Association might or could do if personally present and acting herein.
